APPOINTMENT OF DELEGATES OR PROXIES TO VOTE ON BEHALF OF FULL MEMBER ORGANISATIONS

Deadline for receipt of this form: 7 September 2007

Each full member of ILGA Europe has two votes at the conference, except that if a mixed organisation which has both members who identify as women and members who identify as men sends only delegates who identify as men, then that organisation only has one vote unless it has provided the necessary written confirmation that the women members of that organisation have approved the delegate(s) exercising their vote. Similarly, if a mixed organisation sends only delegates who identify as women, then that organisation only has one vote unless it has provided the necessary written confirmation that the delegate(s) have the authority to exercise both votes. In either case, the women or men in a mixed organisation may instead appoint a proxy. (Standing Orders of ILGA-Europe, 8.4.)

A full member, which is not represented at the conference may appoint a person attending the conference to exercise by proxy the vote or votes to which the organisation is entitled. The member organisation must submit the required notification and also provide the person with a letter of authority. The nominated representative must present this letter of authority in order to receive proxy voting cards. (Standing Orders of ILGA-Europe, 8.5). *No individual may carry more than four (4) proxy votes* (Standing Orders of ILGA-Europe, 8.6.)

This form is to be used by full member organisations:

- To appoint their voting delegates
- To appoint proxies

and by mixed organisations:

- To give authorisation to delegates/proxies of one gender to vote on behalf of the unrepresented gender or appoint a proxy

This form has to be filled in and signed by a legal representative of the member organisation or anyway by a person delegated officially to this task by the member organisation in accordance with its rules.
